

**TERMINATION AND RELEASE OF TRADEMARK COLLATERAL SECURITY AGREEMENT**, dated as of June 28, 2000, among **GRANDY'S, INC.**, a California corporation having its principal place of business at 997 Grandy's Lane, Lewisville, Texas 75077, **SPECTRUM FOODS, INC.**, a California corporation having its principal place of business at 450 Newport Center Drive, Suite 600, Newport Beach, California 92660, **SPOONS RESTAURANTS, INC.**, a Texas corporation having its principal place of business at 450 Newport Center Drive, Suite 600, Newport Beach, California 92660, and **LOCAL FAVORITE, INC.**, a California corporation having its principal place of business at 450 Newport Center Drive, Suite 600, Newport Beach, California 92660 (collectively, the "Assignors") and **U.S. TRUST COMPANY, NATIONAL ASSOCIATION** (f/k/a U.S. Trust Company of California, N.A.), a national banking association with an office at 515 South Flower Street, Suite 2900, Los Angeles, California 90071, as collateral agent (hereinafter in such capacity, the "Collateral Agent") under the Trademark Agreement (as defined herein).

**WHEREAS**, the Assignors, American Restaurant Group, Inc., ARG Enterprises, Inc. and ARG Property Management Corporation (collectively, with the Assignor, the "Borrowers") and the Collateral Agent entered into a Trademark Collateral Security Agreement, dated as of February 25, 1998 (as amended and in effect from time to time, the "Trademark Agreement"), which Trademark Agreement was recorded on May 5, 1998 with the United States Patent and Trademark Office at Reel 1769, Frame 0342 for the purpose of securing payment and performance of the Assignors' obligations under each of (i) the Revolving Credit and Term Loan Agreement, dated as of February 25, 1998, among the Borrowers, the Banks (as defined in the Credit Agreement) and Fleet National Bank (formerly known as BankBoston, N.A.), as Agent for itself and the Banks (as amended and in effect from time to time, the "Credit Agreement"), and (ii) the Indenture, dated as of February 25, 1998, by and among the Borrowers and U.S. Trust Company of California, N.A., in its capacity as Trustee thereunder (the "Indenture");

**WHEREAS**, pursuant to the Security Agreement (as defined in the Credit Agreement) and the Trademark Agreement, each Assignor granted to the Collateral Agent a continuing security interest in and first priority lien on all of the Trademarks, Registrations and Trademark Rights (as defined in the Trademark Agreement and collectively known hereinafter as the "Trademarks"); and

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest and its right, title and interest in and to the trademarks set forth on the attached Schedule A, which is made a part hereof (the "Subject Trademarks");

NOW, THEREFORE, for valuable consideration, and subject to the last sentence hereof:

The Collateral Agent hereby terminates and releases its security interest in and first priority lien on the Subject Trademarks identified on Exhibit A attached hereto, and the Collateral Agent hereby assigns and transfers to each Assignor, without recourse, all of the Collateral Agent's right, title and interest in and to the Subject Trademarks identified on Exhibit A attached hereto, effective as of the date set forth above.
