TRADEMARK RELEASE

THIS TRADEMARK RELEASE (this "Release"), made as of January 5, 2012 by IRISH BANK RESOLUTION CORPORATION LIMITED (f/k/a Anglo Irish Bank Corporation Limited, f/k/a Anglo Irish Bank Corporation PLC) ("Secured Party").

W I T N E S S E T H:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 17, 2007 (as amended, restated, supplemented, or otherwise modified from time to time, including all schedules thereto, the "Security Agreement"), NG NewCo, Ltd. (n/k/a Escher Group Holdings Public Limited Company) ("NG NewCo") and Escher Group, Ltd. (together with NG NewCo, the "Grantors"), have granted to Secured Party a security interest in the Grantors' right, title, and interest in certain trademarks including those set forth in Schedule 1 (the "Trademarks");

WHEREAS, the Security Agreement was recorded in the Assignment Branch, United States Patent and Trademark Office at Reel: 003624, Frame: 0470 on September 19, 2007; and

WHEREAS, at the request of the Grantors, Secured Party has agreed to release its security interest in the Trademarks.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party hereby terminates, releases and discharges its security interest in the Trademark Collateral (as such term is defined in the Security Agreement), including, without limitation, the Trademarks, and re-assigns and releases to the Grantors all right, title and interest that Secured Party has in and to the Trademark Collateral, including, without limitation, the Trademarks. The release set forth above is without recourse, representation, warranty (express or implied) or undertaking by Secured Party to the Grantors.


This Release shall be governed by and construed in accordance with the laws of the State of New York without regard to conflicts of law principles.


