TRADEMARK COLLATERAL AGREEMENT

This 13 day of SEPTEMBER, 2011, Kanetix Ltd. (the "*Debtor*") with its principal place of business and mailing address at 20 Camden Street, Toronto, Ontario, M5V 1V1 in consideration of ten dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, assigns, mortgages and pledges to BMO Capital Corporation (the "*Lender*") with its mailing address at Corporate Finance, 11th Floor, First Canadian Place, Toronto, Ontario, M5X 1A1 and grants to the Lender a continuing security interest in, the following property:

(i) Each trademark and trademark application listed on Schedule A hereto and all of the words, phrases, logos, servicemarks, or other graphical symbols claimed therein and any and all reissues, continuations, continuations-in-part or extensions thereof; and

(ii) All proceeds of the foregoing, including without limitation any claim by the Debtor against third parties for damages by reason of past, present or future infringement of any trademark or trademark application listed on Schedule A hereto, in each case together with the right to sue for and collect said damages,

to secure the payment and performance of all obligations, present and future, direct and indirect of the Debtor to the Lender arising under a credit agreement among the Debtor and the Lender dated September 13, 2011, as such credit agreement may be amended or amended and restated from time to time (the "*Credit Agreement*").

Debtor does hereby further acknowledge and affirm that the rights and remedies of Lender with respect to the assignment, mortgage, pledge and security interest in the trademarks and trademark applications made and granted hereby are more fully set forth in the general security agreement delivered by the Debtor in favour of the Lender in connection with the Credit Agreement.




