**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY (TRADEMARKS)**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (TRADEMARKS)**, dated as of January 6, 2012 ("Release"), is made by MCG CAPITAL CORPORATION, as administrative agent for itself and the Lenders (as defined in the Credit Agreement referred to below) ("Secured Party") in favor of HAWS CORPORATION, a Nevada corporation, and PAGE & FIFTH STREET PROPERTIES, INC., a California corporation (collectively, "Grantor").

**WHEREAS**, pursuant to the Senior Credit Facility Agreement dated as of December 30, 2010 between Grantor, Secured Party, and the Lenders defined therein (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), the Grantor and Secured Party entered into the Security Agreement dated as of December 30, 2010 ("Security Agreement"), and under the Credit Agreement Secured Party and the Lenders agreed to extend certain financial accommodations to Grantor upon the condition, among others, that Grantor grant to Secured Party a security interest in all of Grantor's right, title, and interest in, to, and under all the intellectual property described in Schedule 1 attached hereto (the "Collateral"); and

**WHEREAS**, a Notice of Grant of Security interest in Trademarks related to the Collateral was recorded at the United States Patent and Trademark Office ("USPTO") on December 31, 2010 at Reel 004445 Frame 0145 (the "IP Notice").

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Secured Party and Grantor (the "parties") agree as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Credit Agreement or Security Agreement.

**SECTION 2. Termination and Release.** Secured Party hereby:

(a) terminates Credit Agreement, Security Agreement, IP Notice, and any other agreement under which Grantor has granted a collateral mortgage, pledge, hypothecation, grant, assignment, lien, or security interest in, to, and under the Collateral;

(b) cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under the Collateral; and


(c) authorizes the recordation of this Release with the USPTO.
