FIRST AMENDMENT TO PATENT AND TRADEMARK SECURITY AGREEMENT

THIS FIRST AMENDMENT TO PATENT AND TRADEMARK SECURITY AGREEMENT (the "Amendment"), is dated January 4, 2012, and entered into by and between E. F. JOHNSON COMPANY, a Minnesota corporation ("Company"), and WELLS FARGO BANK, NATIONAL ASSOCIATION ("Wells Fargo"), acting through its Wells Fargo Business Credit operating division.

RECITALS

A. Company and Wells Fargo are parties to a Credit and Security Agreement dated August 13, 2010 (as amended, supplemented or restated from time to time, the "Credit Agreement"). Capitalized terms used in these recitals have the meanings given to them in the Credit Agreement unless otherwise specified.

B. To induce Wells Fargo to provide the financial accommodations described in the Credit Agreement, Company entered into that certain Patent and Trademark Security Agreement, dated as of August 13, 2010 with Wells Fargo (the "Agreement").

C. The Company has requested that Wells Fargo modify and amend certain terms of the Agreement as set forth herein.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants and agreements herein contained, it is agreed as follows:

1. Amendments to the Agreement.

(a) Section 3.2 of the Agreement. The first sentence of Section 3.2 of the Agreement is hereby amended by replacing each reference to "the date hereof" appearing therein with "January 4, 2012".

(b) Section 3.3 of the Agreement. The first sentence of Section 3.3 of the Agreement is hereby amended by replacing each reference to "the date hereof" appearing therein with "January 4, 2012".






