ASSIGNMENT OF TRADEMARK RIGHTS

This Assignment of Trademark Rights ("Assignment") is entered into as of October 14, 2011 (the "Effective Date") by and between Gamedoctors GmbH & Co. RECITALS

A. Assignor is the owner of record of the following United States trademark applications: Application Serial No. 85370785 for ZOMBIESMASH! and Application Serial No. 85370813 for ZOMBIE SMASH! (Stylized) (collectively "the Applications").

B. Assignor is desirous of assigning to Assignee all right, title, interest and goodwill in the Applications and all related rights. Assignee is desirous of accepting such assignment.

NOW THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the parties agree as follows.

AGREEMENT

1. Assignment. Assignor hereby assigns to Assignee all right, title and interest in and to the Applications and all related rights, together with that portion of Assignor's business relating to the Applications and the goodwill appurtenant thereto. Assignee accepts such assignment.

2. Execution and Delivery. Assignor agrees to execute and deliver all papers, instruments and assignments and to perform any other reasonable acts the Assignee may require in order to vest all right, title and interest in and to the Applications and any related rights to the Assignee and/or provide evidence to support any of the foregoing in the event such evidence is necessary to effectuate the assignment, to the extent such evidence is in the possession or control of Assignor.
