PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS PARTIAL RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Release") is made as of January 1, 2012 (the "Effective Date") by The Bank of Nova Scotia, as administrative agent (in such capacity, the "Administrative Agent") for the benefit of Ashland Licensing and Intellectual Property LLC (the "Grantor").

WHEREAS, pursuant to the terms and conditions of that certain Security Agreement, dated as of August 23, 2011, between the Borrower, the Grantor, the other guarantors party thereto and the Administrative Agent (the "Security Agreement"), and that certain Trademark Security Agreement, dated as of August 23, 2011, between the Grantor, the other parties thereto and the Administrative Agent (the "Trademark Security Agreement"), the Grantor pledged, assigned and granted to the Administrative Agent a continuing security interest in all of its right, title and interest in and to certain collateral including, without limitation, the trademark registrations set forth on Schedule I hereto along with the good will associated therewith (collectively, the "Trademarks");

WHEREAS, the Trademark Security Agreement was recorded with the Trademark Division of the United States Patent and Trademark Office on September 16, 2011, at Reel 4625 and Frame 0303;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby terminates, solely as to the Trademarks, the Trademark Security Agreement, and hereby terminates, cancels, re-pledges, reassigns and releases any and all security interests it has against the Trademarks.

If and to the extent the Administrative Agent has acquired any right, title or interest to any of the Trademarks, it hereby assigns and transfers such rights, title or interest to the Grantor.

The Administrative Agent shall take all further actions, and provide to the Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), requested by the Grantor to more fully and effectively effectuate the purposes of this Release.
