This Agreement is made between:

(1) **Whyte and Mackay Limited**, incorporated under the Companies Act in Scotland with registered number SC014456 and having its registered office at Dalmore House, 310 St Vincent Street, Glasgow, G2 5RG, United Kingdom (hereinafter called "the Chargor");

AND

(2) **Coöperatieve Centrale Raiffeisen - Boerenleenbank B.A. (trading as Rabobank International), Hong Kong Branch**, of 10/F York House, The Landmark, 15 Queen's Road Central, Hong Kong as agent and trustee for the other Finance Parties (as that term is defined in the Facility Agreement defined in the Security Agreement referred to below) and its successors and assignees whomsoever as such trustee from time to time (hereinafter called "the Security Agent")

WHEREAS

- (A) The Chargor is the proprietor of the Trade Mark Applications and Registrations listed in Annexure "A" attached hereto (hereinafter called "the Trade Marks"); and
- (B) The Chargor and the Security Agent have entered into a Security Agreement dated 22 August 2011 (hereinafter called "the Security Agreement") pursuant to which the Chargor has granted the Security Agent a security interest in all of Chargor's right, title and interest in and to the Trade Marks set forth in "Annexure A"; and
- (C) This Confirmatory Agreement confirms and formally records the Security Agreement.

NOW THEREFORE


The Chargor and the Security Agent are executing this Confirmatory Agreement for recordal purposes in any official register, including, without limitation, the official register of Trade Marks in each of the countries identified in Annexure A; and

This Confirmatory Agreement shall terminate automatically on the termination for any reason of the Security Agreement.
