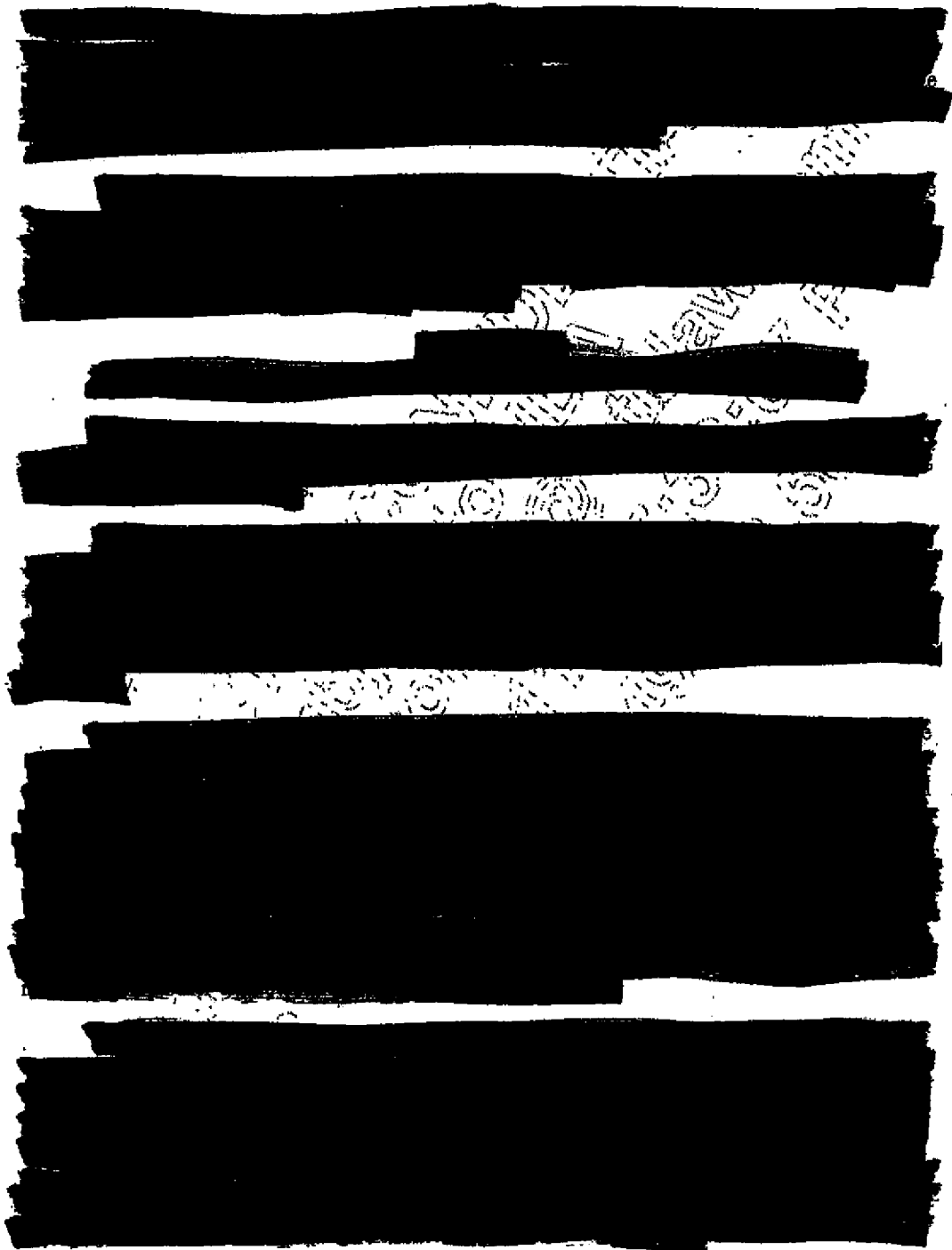

EXCHANGE OF SHARES

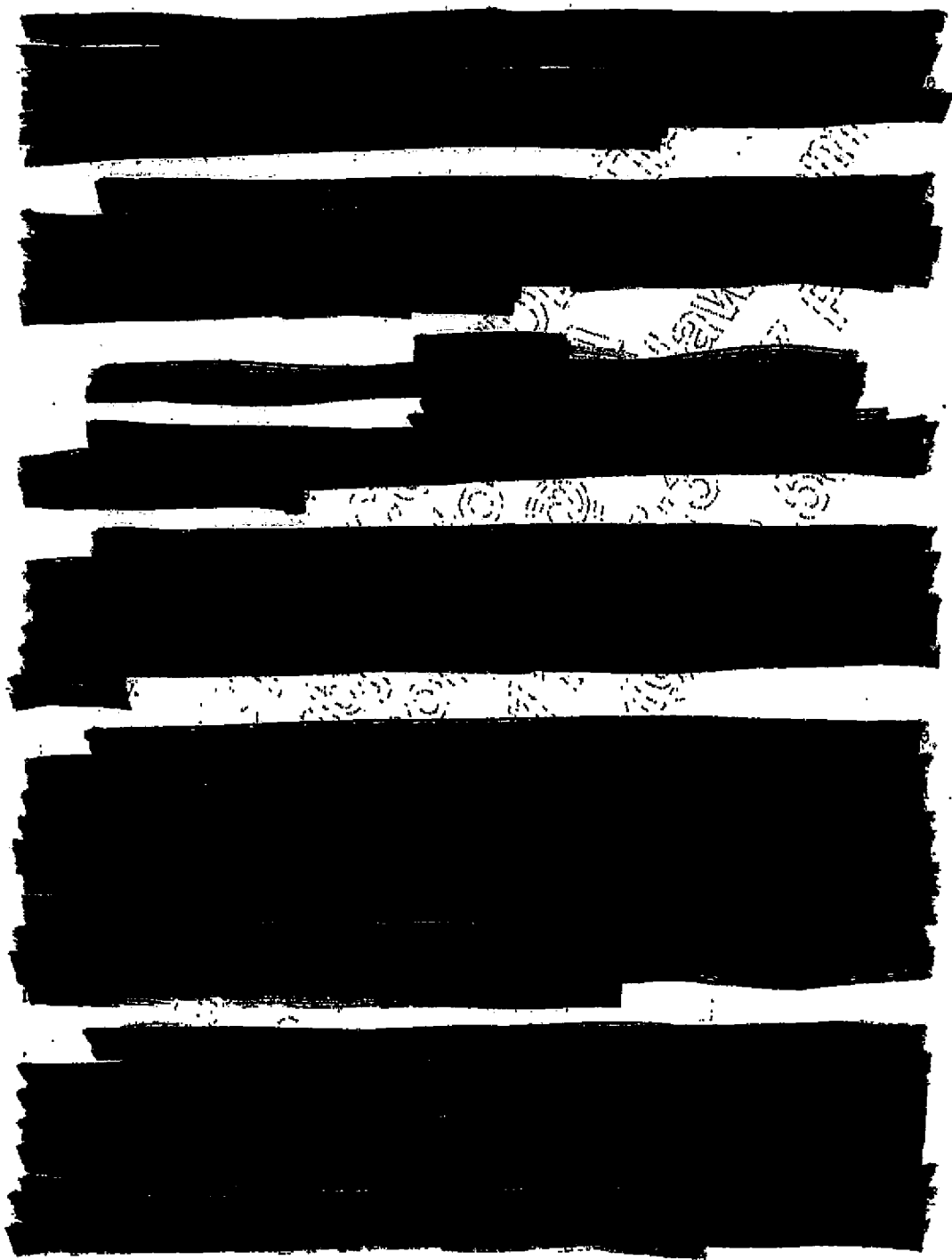
