RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST having an effective date of January 17, 2012 by PNC Bank, National Association, ("Grantee"), in favor of Advanced Drainage Systems, Inc., a Delaware corporation, Hancor, Inc., an Ohio corporation, and PSA, Inc., a Maine corporation (collectively, the "Grantors").

WHEREAS, Grantors and Grantee are parties to a certain Patent, Trademark and Copyright Security Agreement dated as of September 24, 2010 (the "Security Agreement"), and recorded in the United States Patent and Trademark Office on September 27, 2010 at Reel 025039, Frame 0556 (Patents) and at Reel 4284, Frame 0512 (Trademarks) under which Grantors granted Grantee a security interest in certain patent, trademark and copyright collateral including but not limited to the trademarks listed on the schedule attached hereto; and

WHEREAS, Grantee has requested that Grantor release the security interest solely to those trademark registrations, patents and patent applications listed on the attached Schedule A (the "IP Collateral").

WHEREAS, Grantee desires to assign, release, terminate, discharge, grant, convey, deliver and transfer its continuing security interest in all of the IP Collateral to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Grantee hereby terminates, releases and discharges fully its lien on, and security interest in and to, all of the right, title and interest of the Grantors in, to and under the IP Collateral and reassigns and transfers any and all interest that Grantee may have in the IP Collateral to the Grantors.
