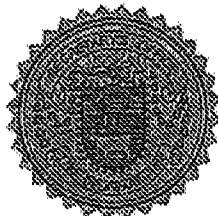

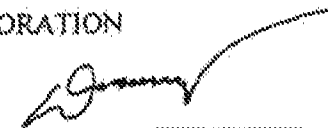
HID Corporation hereby certifies that:
