RELEASE OF SECURITY INTEREST



NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged, Lender hereby terminates the Security Interest and releases to Borrower all interest which Lender possesses or is otherwise entitled to in the Trademarks and Patents.


