WHEREAS, Assignee wishes to terminate the Agreements and release, retransfer and reassign to Assignor, without representation or warranty, all of Assignee's right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Assignee hereby terminates the Agreements and releases, retransfers and reassigns to Assignor, without representation or warranty, all of Assignee's right, title and interest in and to the Marks and the goodwill associated therewith.
