Agent wishes to release to Grantor, without representation or warranty, all of Agent's right, title and interest in and to the Released Marks, the goodwill and assets of the business, and the Released Patents.

For good and valuable consideration, receipt and sufficiency of which is hereby acknowledged, Agent, on behalf of itself and the lenders, its successors, legal representatives and assigns, hereby releases and discharges fully its security interest in and to the Released Marks and the Released Patents, without representation or warranty of any kind, express or implied, free and clear of any claims by Agent, all of Agent's right, title and interest in and to the Released Marks, the goodwill and assets of the business, the Released Patents, and all causes of action for past infringement, if any.
