**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

TERMINATION AND RELEASE dated as of January 11, 2012 from JPMorgan Chase Bank, N.A., as Administrative Agent (the "Agent") for the Lenders, to Telcordia Technologies, Inc., a Delaware corporation and Granite Systems, Inc., a Delaware corporation (together, the "Obligors").

**WITNESSETH:**

WHEREAS, pursuant to that certain First Lien Security Agreement, dated as of April 30, 2010, made by the Obligors in favor of the Agent (the "First Lien Security Agreement"), a security interest (the "Security Interest") was granted by the Obligors to the Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Trademark Security Agreement, dated as of April 30, 2010, made by the Obligors in favor of the Agent (the "Trademark Security Agreement"), the Obligors, by reference to the First Lien Security Agreement, reaffirmed their intent to grant a Security Interest to the Agent specifically in certain Trademark Collateral;

WHEREAS, the Trademark Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on June 12, 2010, at Reel 4223 and Frame 0656; and

WHEREAS, the Obligors have requested that the Agent: (a) terminate and release the liens and interests of the Agent in the Trademark Collateral; and (b) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office.

WHEREAS, the Obligors have satisfied and fulfilled all of their obligations to release the Agent's security interest in the Trademark Collateral under the First Lien Security Agreement, and the parties seek to make of record of Agent's release and reassignment to the Obligors of any and all of its security interests in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration including the satisfaction of all obligations, indebtedness and liabilities secured by the Trademark Collateral pursuant to the First Lien Security Agreement, the receipt and adequacy of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Definitions. The term "Trademark Collateral," as used herein, shall mean all of the Obligors' right, title and interest of every kind and nature in the Trademarks listed on Schedule A hereto, including all (a) registrations and applications for registration for any of the foregoing, together with all goodwill of the business connected with the use of or symbolized by each Trademark; (b) each Trademark license to which any Obligor is a party, and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark licensed thereto; (c) rights in the foregoing provided by international treaties or conventions, rights

corresponding thereto throughout the world and other rights of any kind of such Obligors accruing thereunder or pertaining thereto; and (d) all Proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and Supporting Obligations relating to, any and all of the foregoing, including, without limitation, all Proceeds of and revenues from any claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, all proceeds and damages relating thereto. The term "Trademarks" and any other term used herein and not otherwise defined shall have the meaning set forth in the First Lien Security Agreement.

2. Release of Security Interest. The Agent hereby terminates, releases, discharges and reassigns to the Obligors its Security Interest in the Trademark Collateral, and any right, title or interest of the Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances. The Agent hereby agrees to duly execute, acknowledge, procure and deliver, at the sole expense of Obligor or its successors and assigns, any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

4. Governing Law. This Termination and Release shall be governed by, and construed in accordance with, the laws of the State of New York.
