## INTELLECTUAL PROPERTY ASSIGNMENT

THIS INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the “**Assignment**”) is made in Montreal as of the 20<sup>th</sup> day of December, 2011 (the “**Effective Date**”).

**BY AND BETWEEN:**                    **RAYMOND CHABOT INC.**, a corporation duly incorporated under the laws of the Province of Québec, having its principal office at 2000 De La Gauchetière West Street, Suite 600, Montreal (Québec), H3B 4L8, Canada, herein acting in its capacity as receiver to the assets of Procaps L.P., Procaps G.P. Inc. and 9084-9654 Québec Inc.;

(the “**Assignor**”)

**AND:**                                    **G.I. SPORTZ INC.**, a corporation duly incorporated under the laws of Canada, having a place of business at 1375 32nd Avenue, Lachine (Québec), H8T 3H2, Canada;

(the “**Assignee**”)

**WHEREAS** the Assignor was appointed receiver to the assets, undertakings and properties of Procaps L.P., Procaps G.P. Inc. and 9084-9654 Québec Inc. pursuant to three (3) judgments dated December 7, 2011 in the court files bearing the court numbers 500-11-041788-114, 500-11-041789-112 and 500-11-041790-110;

**WHEREAS** the Assignor wishes to assign to the Assignee all right, title and interest in and to all Intellectual Property of Procaps L.P., Procaps G.P. Inc. and 9084-9654 Québec Inc. (collectively, “Procaps”), including without limitation all patents, trade-marks, industrial designs and any other intellectual property assets, as set out in **Section 1** hereunder (collectively, the “**Intellectual Property**”);

**WHEREAS** pursuant to a deed of sale executed as of this day between the Assignor and the Assignee (the “**Deed of Sale**”), the Assignor sold, assigned and transferred and the Assignee purchased the Assets ( as defined in the Deed of Sale ) including the Intellectual Property;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Assignor hereby sells, assigns and transfers to the Assignee and its successors, assigns and nominees absolutely and forever, the entire right, title and interest in and to the Intellectual Property, on an as is, where is basis, without warranty whatsoever

- (a) all inventions, discoveries, processes, techniques, developments and related improvements whether or not patentable;
- (b) all industrial designs, patents, patent applications, divisionals, continuations, reissues, renewals, registrations, confirmations, re-examinations, extensions and any provisional applications, or any such patents or patent applications, and any foreign or international equivalent of any of the foregoing, including but not limited to the items listed on **Exhibit A** hereto;
- (c) all registered, unregistered or pending trademarks, trade dress, service marks, service names, trade names, brand names, logos, domain names, or business symbols and any foreign or international equivalent of any of the foregoing and all goodwill associated therewith and any applications in connection with the foregoing including but not limited to the items listed on **Exhibit B** hereto;
- (d) all work specifications, software (including object and source code listing) and artwork;
- (e) all technical, scientific and other know-how and information, trade secrets, methods, processes, practices, formulas, designs, assembly procedures, specifications owned or used by Procaps;
- (f) all copyrights and work for hire;
- (g) all assets used or useful by Procaps in the conduct of its business over the internet or in any electronic medium, including any websites or domain names owned by Procaps;
- (h) all assignments, transfers, permissions, rights or licenses granted to Procaps relating to any of the foregoing, whether, express, implied or by operation of law;
- (i) all accounts, contract rights, claims, and general intangibles (including payment intangibles) relating to any of the foregoing including but not limited to all licenses and settlements relating to the foregoing;
- (j) the settlement agreement effective as of May 30, 2008 by and among KEE Action Sports LLC, KEE Action Sports I LLC and Procaps L.P. (the "**KEE Settlement Agreement**");
- (k) all other rights of every kind whatsoever accruing thereunder or pertaining thereto whether arising in the past, concurrently with the closing of this agreement or thereafter, and

- (l) all claims for and rights to damages or other relief by way of past, present and future infringements of any of the foregoing.


Each of the foregoing to be held and enjoyed by Assignee, for its own use and benefit, and for its successors and assigns to the full end of the term for which such rights may exist in any country, as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made.

2. The Assignee hereby accepts the sale, assignment and transfer by the Assignor set out in paragraph 1 hereof. Moreover, the Assignee agrees to observe and perform all of the duties, obligations, terms, provisions, undertakings and covenants of the KEE Settlement Agreement which arise after the date hereof.
3. The Assignor hereby authorizes the Assignee to request the relevant Intellectual Property Offices to record the Assignee as the assignee and owner of the Intellectual Property.
4. This Assignment is effective as of the Effective Date. The Assignor shall, without further consideration, comply with any reasonable request by Assignee to execute and deliver promptly any additional documents and do such further acts and things as may be necessary in order to give effect to the assignment of rights reflected herein.
5. Subject to any applicable legislation, the parties agree that the assignment of each Intellectual Property asset shall be construed as separable and divisible from the assignment of every other Intellectual Property asset. The unenforceability or invalidity of this Assignment with respect to any one Intellectual Property asset shall not limit its enforceability or validity, in whole or in part, with respect to any other Intellectual Property asset.
6. This Assignment, together with the Offer, represents the entire agreement between the parties with respect to the ownership and assignment of the Intellectual Property, and supercedes any and all prior agreements, understandings and communications between the parties, whether oral or written, with respect thereto.
7. This Assignment shall be construed and enforced in accordance with the laws of the Province of Québec and the laws of Canada applicable therein.
8. The parties hereby agree that this Assignment and all documents used to effect this transaction will be in English language. *Les parties aux présentes conviennent que la présente cession et tous les documents s'y rapportant soient rédigés en langue anglaise seulement.*
9. This Assignment shall enure to the benefit of and be binding upon the parties hereto and their respective successors and assigns.


