RELEASE OF INTELLECTUAL PROPERTY SECURITY INTEREST

This Release of Intellectual Property Security Interest ("Release") is made this 6<sup>th</sup> day of October, 2011 by Joseph R. Gregory, a Tennessee resident (collectively, the "Secured Party") in favor of Epic Secure Solutions, Inc., f/k/a Bsafe Online, Inc., a Texas corporation (the "Debtor").

WHEREAS, in connection with the Security Agreement, Debtor granted to Secured Parties a security interest in all of Debtor's right, title and interest in, to and under its current and future copyrights, patents and trademarks, including without limitation, those copyright, patent and trademark registrations and applications listed on Schedule A, Schedule B and Schedule C hereto, including without limitation all proceeds thereof (such as, by way of example but not by way of limitation, license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements, all rights corresponding thereto throughout the world and all re-issues, divisions, continuations, renewals, extensions and continuations-in-part thereof (collectively, the "Intellectual Property Collateral").


WHEREAS, Debtor has fully paid the indebtedness owing under the Security Agreement, and Secured Party desires to release and discharge his security interest in and to the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Secured Party hereby releases any and all right, title and interest to his security interest in and to the Intellectual Property Collateral, and reassigns any and all interest it may have in the Intellectual Property Collateral to Debtor. The Security Agreement is hereby terminated.
