## ASSIGNMENT OF MARKS

WHEREAS, pursuant to a Stock Purchase Agreement dated as of December 23, 2008 (Stock Purchase Agreement), by and among Pelican Products, Inc., a Delaware corporation ("Assignee"), and the shareholders of Hardigg Industries, Inc., a Massachusetts corporation ("Assignor"), Assignee acquired 100% ownership of all of the stock of Assignor;

WHEREAS, Assignor was the holder of all right, title and interest to the marks listed in Attachment A ("the Hardigg Marks") and the goodwill associated therewith, with these rights having been exercised by Assignor;

WHEREAS, Assignor was the holder of all right title and interest in the domain names and URLs listed in Attachment B ("Hardigg Domain Names");

WHEREAS, pursuant to the Stock Purchase Agreement, Assignee acquired all rights of any kind worldwide, registered and unregistered, in the Hardigg Marks and all the goodwill of the business connected with and symbolized by the Hardigg Marks;

WHEREAS, pursuant to the Stock Purchase Agreement, Assignee acquired all of Assignor's rights in the Hardigg Domain Names;

WHEREAS, the shareholders of Assignor and the Assignor have quitclaimed and effectively transferred in fact all rights in the Hardigg Marks and the Hardigg Domain Names to Assignee;

WHEREAS, since Assignee acquired Assignor under the Stock Purchase Agreement, under Assignee's ownership and direction, Assignor has continued to operate the business and use the Hardigg Marks and Hardigg Domain Names in operation of the business;

WHEREAS, Assignor has yet to execute a formal United States or worldwide trademark assignment document; and

WHEREAS, said Assignee now desires such formal assignment in order to record the same in the United States Patent and Trademark Office and worldwide;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and conveys to Assignee all worldwide right, title and interest in and to the Hardigg Marks, whether registered or unregistered, as well as all registrations and applications to register any of the Hardigg Marks anywhere in the world, all of Assignor's rights in the Hardigg Domain Names, and that part of the good will of the business connected with and symbolized by the Hardigg Marks and the Hardigg Domain Names, as well as all rights to injunctive relief, damages or profits, due or accrued, arising out of past infringement of the Hardigg Marks and/or Hardigg Domain Names or injury to the said good will, and the right to sue for and recover the same in its, the Assignee's own name.

This assignment being under covenant, not only that full power to make the same is had by the Assignor, but also that the assigned rights are not encumbered by any grant, license, or

other right heretofore given; Assignor acknowledges that, subject to any reservation of rights specified in said Stock Purchase Agreement, Assignor shall not, without the prior written consent of the Assignee, use or seek to register any of the Hardigg Marks, the Hardigg Domain Names or any variation thereof or any mark, domain name, URL or other designation confusingly similar thereto, directly or indirectly, as a principal, agent, shareholder, investor, employer, partner, member, joint venturer, manager, consultant, operator, or in any other capacity whatsoever anywhere in the world, in connection with the same or similar or related goods and services associated with the Hardigg Marks and/or the Hardigg Domain Names, now or in the future, nor shall Assignor trade on the goodwill associated with the Hardigg Marks and/or the Hardigg Domain Names or bring proceedings or otherwise challenge Assignee's exclusive rights to use and register the Hardigg Marks and/or Hardigg Domain Names worldwide, such exclusive rights to be held and enjoyed by Assignee for its own use and for its legal representatives and assigns as fully and entirely as the same would have been held by Assignors had this assignment not been made.

IN WITNESS WHEREOF, the undersigned have executed this Assignment of Hardigg Marks and Hardigg Domain Names.
