**TERMINATION AND RELEASE OF SECURITY INTERESTS
IN TRADEMARKS**


WHEREAS, MULTI-PLASTICS, INC., an Ohio corporation, MULTI-PLASTICS EXTRUSIONS, INC., an Ohio corporation, and MPI HOLDINGS, INC., an Ohio corporation (the collectively, the "Grantors"), entered into a Trademark Security Agreement, dated as of January 28, 2010 (as from time to time amended, modified or supplemented, the "Trademark Security Agreement") between the Grantors and Reynolds Packaging, Inc, as secured party ("Reynolds"), pursuant to which the Grantors granted a security interest (the "Security Interest") in certain trademarks, including without limitation the trademarks set forth on the attached Schedule A (the "Trademarks"); and

WHEREAS, Trademark Security Agreement was recorded in the United States Patent and Trademark Office on February 17, 2010 at Reel 004150, Frame 0551 (Trademarks) under which Grantors granted Reynolds a security interest in certain trademark collateral including but not limited to the trademarks listed on the schedule attached Schedule A hereto; and

WHEREAS, all of the secured promissory notes of Grantors owing to Reynolds have been fully paid and satisfied and the Reynolds desires to release the Security Interest,


NOW THEREFORE, in consideration of the foregoing and intending to be legally bound, Reynolds hereby releases the Security Interest, and hereby, (i) waives and relinquishes all its rights, powers, privileges and remedies under the Trademark Security Agreement, (ii) sells, assigns, conveys, transfers and sets over to the Grantors any right, title or interest that Reynolds may have acquired and re-vests in each such Grantor the full unencumbered title to the Trademarks and the goodwill associated therewith, and (iii) releases each Grantor from all covenants, obligations, liabilities and warranties under the Trademark Security agreement.
