### Nunc Pro Tunc Trademark Assignment

This Trademark Assignment is effective as of December 31, 2002, (the "Effective Date") by and between HID Corporation, a Delaware corporation, currently known as HID Global Corporation ("Assignor"), and Indala Corporation ("Assignee").

WHEREAS, as of the Effective Date, Assignor assigned trademark rights and the parties now desire to memorialize and confirm the transfer of certain trademark properties therein transferred, along with the corresponding goodwill.

NOW, THEREFORE, for good and valuable consideration, the parties hereby agree as follows:

1. Assignor hereby sells, assigns and transfers to Assignee, its successors, assigns and legal representatives, effective, *nunc pro tunc*, as of December 31, 2002, all right, title and interest in and to the trademarks, trade names, service marks and logos listed on Schedule 1 attached hereto (collectively, the "Trademarks") together with all corresponding goodwill and any and all other rights and privileges provided under the laws of all relevant jurisdictions, including without limitation the laws of the United States, of the various states, and of foreign (i.e. non-US) jurisdictions with respect to the Trademarks, including the laws of unfair competition; and any and all rights in, to and under any and all licenses and other agreements and documents relating to any of the foregoing.

2. Assignor further grants, conveys and assigns effective, *nunc pro tunc*, as of December 31, 2002 to Assignee all its right, title and interest in and to any and all proceeds, causes of action and rights of recovery for past, current and future infringement or misappropriation of any of the Trademarks.

3. The Trademarks are conveyed subject to any and all licenses, permissions, consents or other rights that may have been granted by Assignor or its predecessors-in-interest with respect thereto prior to the Effective Date.

4. This Agreement may be executed in counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.

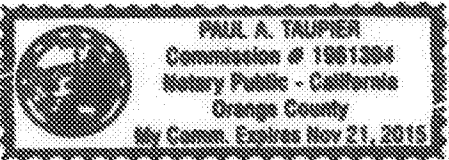
