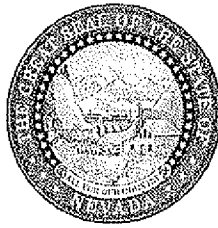



WHEREAS, the name change requires an amendment to the Operating Agreement and notification or filing with the state of Nevada;


