**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

WHEREAS **Delavau L.L.C.**, a Delaware limited liability company with an address at 10101 Roosevelt Boulevard, Philadelphia, Pennsylvania 19154 (the "Grantor"), entered into that certain security agreement dated as of September 20, 2002 and amended and restated as of August 13, 2003 (the "Security Agreement") with **Deutsche Bank AG**, Cayman Islands Branch, with principal offices at 31 West 52<sup>nd</sup> Street, 7<sup>th</sup> Floor, New York, New York 10019, (the "Collateral Agent").

WHEREAS, Grantors granted the Collateral Agent, under the terms of the Security Agreement, a continuing security interest (the "Security Interest") in favor of the Collateral Agent, in and to certain of Grantors' intellectual property, including, without limitation, the trademarks listed in Schedule A (collectively, the "Trademarks") and all of the goodwill of the business connected with the use of, and symbolized by the Trademarks. Notice of this assignment of security interest was recorded on January 13, 2003 and May 10, 2010 at the United States Patent and Trademark Office at Reel/Frame Nos. 2651/0406 and 4201/0924, respectively.

WHEREAS, the Collateral Agent has agreed to terminate and release its security interest in all such Trademarks as herein provided.

NOW, THEREFORE, in consideration of the foregoing and intending to be legally bound, the Collateral Agent, for itself and on behalf of the lenders in association with the Security Interest, hereby releases, terminates and discharges all liens and the Security Interest, hereby waives and relinquishes all its rights, powers, privileges and remedies with respect to Grantors and its successors and assigns in association with the Security Interest, and hereby releases Grantors and its successors and assigns from all covenants, obligations, liabilities and warranties in association with the Security Interest.
