WHEREAS, Assignor has adopted and used the trademark listed in Schedule A attached hereto (the "Trademark");


WHEREAS, Assignor has filed an application with the United States Patent & Trademark Office for registration of the Trademark listed in Schedule A attached hereto (the "Application");
