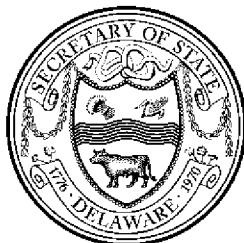



1. The name and state of incorporation of each of the constituent entities are:
  - a. Husqvarna Turf Care, LLC, a Delaware limited liability company ("Turf Care");  
and
  - b. Husqvarna Consumer Outdoor Products N.A., Inc., a Delaware corporation  
("HCOP").
2. An Agreement and Plan of Merger (the "Merger Agreement") has been approved, adopted, certified, executed and acknowledged by each of the constituent entities in accordance with the provisions of Section 264(b) of the General Corporation Law of the State of Delaware.
3. Pursuant to the Merger Agreement, Turf Care will merge with and into HCOP (the "Merger").
4. The name of the surviving corporation is Husqvarna Consumer Outdoor Products N.A., Inc. (the "Surviving Corporation"). The Surviving Corporation is a Delaware corporation.
5. The Certificate of Incorporation of the Surviving Corporation immediately prior to the Effective Time (as defined in the Merger Agreement) shall be the Certificate of Incorporation of the Surviving Corporation after the Merger.
6. The executed Merger Agreement pursuant to which the Merger is being consummated is on file at the principal place of business of the Surviving Corporation. The address of the principal place of business of the Surviving Corporation is 9335 Harris Corners Parkway, Suite 500, Charlotte, NC 28269.

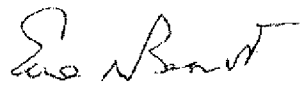
7. A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of HCOP and to any member of Turf Care.
