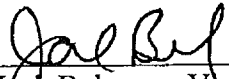
CERTIFICATE OF AMENDMENT OF  
ARTICLES OF INCORPORATION

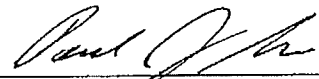
The undersigned certify that:
