TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT ("Assignment") is made and entered into this 16th day of January, 2012 by and between YKK AP America Inc., a New York corporation ("Assignor"), and YKK Corporation of America, a New York corporation ("Assignee").

WITNESSETH:

WHEREAS, Assignor has adopted, is using, and is the sole owner of the trademarks indicated on Appendix A (the "Trademarks"), attached hereto;

WHEREAS, the Trademarks are valuable intellectual property rights of Assignor;

WHEREAS, Assignee desires to acquire the Trademarks; and

WHEREAS, Assignee and Assignor desire to enter into this Assignment to effect the transfer of the Trademarks on the terms and conditions contained herein.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

1. Transfer and Assignment. In consideration of the payment of One Dollar (\$1.00), Assignor does hereby transfer and assign unto Assignee the entire right, title, and interest in and to the Trademarks, the renewals thereof, all registrations issued thereto, and all of the properties, rights and obligations relating thereto, including the right to recover for damages and profits and other remedies for past infringement of the Trademarks, and the right to register and maintain the Trademarks in the United States Patent and Trademark Office and any other appropriate governmental authority or agency of the United States or of any other country. The Trademarks have been registered with the United States Patent and Trademark Office under the registration numbers indicated on Appendix A; such registrations and all rights thereunder are hereby transferred and assigned by Assignor to Assignee.

2. License for Assignor. Assignee hereby grants to Assignor a perpetual, non-exclusive, world-wide, royalty-free, unrestricted license to use the Trademarks for any purpose, including, without limitation, the right to sublicense the Trademarks to any or all of Assignor's subsidiaries and affiliates.

3. Further Documentation and Actions. Assignor and Assignee each hereby agrees to execute and deliver to the other any further documents and instruments, and to do any and all further acts and deeds, deemed necessary by either of them to vest in each of them all of the rights granted to such party hereunder.


4. Effective Date. This Assignment shall be effective as of the date set forth above.

IN WITNESS WHEREOF, the parties hereto have executed this Assignment as of the date set forth above.


