## NUNC PRO TUNC TRADEMARK ASSIGNMENT

NOW, THEREFORE, for good and valuable consideration, the full receipt and sufficiency of which are hereby acknowledged and intending to be legally bound hereby, Assignor hereby acknowledges that it has sold, assigned, transferred and conveyed unto Assignee the whole and entire right, title and interest in and to the Marks listed in Schedule A, and any registrations and applications for registration related thereto, whether in the United States or foreign countries, together with the goodwill of the business symbolized by the Marks, and all rights and privileges granted and secured thereby, the Marks to be held and enjoyed by Assignee for its own use and behoof, and for Assignee's legal representatives and assigns to the full end of the term for which said applications and registrations as fully and entirely as the same would have been held by Assignor had this assignment and sale not been made. Assignor further assigns to Assignee all rights to sue, bring actions and recover and hold damages, profits and other compensation for any and all past, present and future infringements and unauthorized uses of the Marks.

Assignor covenants and agrees that, upon the request of Assignee, Assignor shall execute all papers, make all rightful oaths, testify on behalf of Assignee, furnish such documents, materials, information and/or assistance, and do all other lawful acts necessary to perfect the assignment of the Marks to Assignee and otherwise carry out the intent of this Assignment.

This Assignment shall be binding upon Assignor, Assignor's successors and assigns, and upon all others acting by, through, with or under Assignor's direction or control, and all those in privity therewith.

A facsimile or photocopied signature (which may be delivered by facsimile or other electronic means) shall be deemed to be the functional equivalent of an original for all purposes.

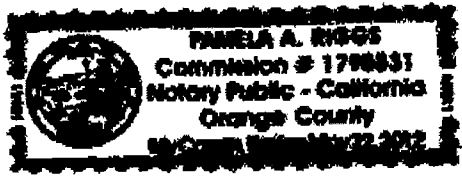

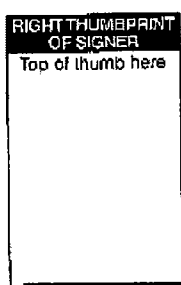

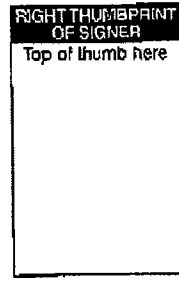
