TRADEMARK ASSIGNMENT AGREEMENT

This TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement"), dated as of January 25, 2012, by and between Silver Bracelets, Inc., a Nevada corporation having its principal offices at 6052 Turkey Lake Road, Orlando, Florida U.S.A (hereinafter referred to as "Assignor"), and OCS Consultants, Inc., a Florida corporation having its principal offices at 6052 Turkey Lake Road, Orlando, Florida 32819, U.S.A. (hereinafter referred to as "Assignee").

A. Assignor owns the following trademarks: (i) EARL'S COURT (Serial. No. 85/150916); and (ii) EARL'S COURT (Serial. No. 85/256086); (collectively, the "Trademarks") and has the right to assign all right, title and interest in and to the Trademarks; and

B. Assignee desires to obtain all of Assignor's right, title and interest in and to the Trademarks.

NOW, THEREFORE, in consideration of the payment of one hundred dollars (\$100.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. **Assignment.** Assignor hereby conveys, transfers, assigns and delivers to Assignee all of Assignor's right, title, and interest of whatever kind in and to the Trademarks including: (a) all income, royalties, and damages hereafter due or payable to Assignor with respect to the Trademarks, including without limitation, damages, and payments for past or future infringements and misappropriations of the Trademarks; and (b) all rights to sue for past, present and future infringements or misappropriations of the Trademarks.

2. **Further Assurances.** Assignor further covenants that it will execute all documents, papers, forms and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title and interest in the Trademarks.

3. **Entire Agreement.** This Agreement contains the entire agreement between the parties concerning the subject matter herein.
