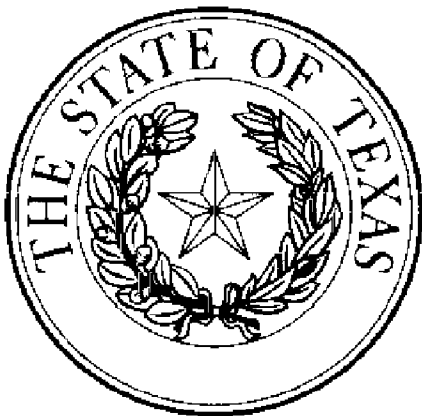

5. The amendment changes the certificate of formation to change the article or provision that names the filing entity. The article or provision is amended to read as follows:


