

PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS PARTIAL RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of January 27, 2012, by Wells Fargo Bank, National Association, in its capacity as Collateral Agent (in such capacity, the "Collateral Agent"), in favor of Nashua Corporation (the "Grantor").

WHEREAS, reference is made to that certain Indenture dated as of February 5, 2010 (the "Indenture"), between Cenveo Corporation (the "Issuer"), the Guarantors party thereto and Wells Fargo Bank, National Association as Trustee with respect to the Issuer's 8.875% Senior Second Lien Notes due 2018 and the Security Agreement. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed to them in the Indenture.

WHEREAS, pursuant to the terms and conditions of the Indenture and the Security Agreement, the Grantor granted to the Collateral Agent a continuing lien on and security interest in and to all of its right, title and interest in, to and under the trademarks of the Grantor set forth on Schedule I hereto (the "Trademarks").

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby terminates, cancels, re-pledges, reassigns and releases to the Grantor and the other Guarantors any and all liens and security interests the Collateral Agent has against the Trademarks.

If and to the extent the Collateral Agent has acquired any other right, title or interest to any of the Trademarks, it hereby re-assigns and re-transfers such rights, title or interest to the respective Guarantors, including, but not limited to, any and all rights to sue for and collect damages for past, present and future infringements thereof.

This Release shall be construed in accordance with and governed by the laws of the State of New York.
