Releasor further covenants that it will take no action in the future that will prejudice Owner's rights in and to the Mark(s), but Releasor otherwise does not by this Instrument warrant that it now has any such rights or title in or to the Mark(s).

This Release, Quitclaim and Assignment shall be binding on Releasor and Releasor successors, legal representatives and assigns.
