This Trademark Assignment (this "Assignment") is effective as of March 28, 2006 by and between Source Media Inc., a Delaware Corporation ("Assignor"), and Accuity ~~LLC~~, a Delaware ~~limited liability~~ corporation ("Assignee").

5 WHEREAS, the Parties have entered into an Asset Contribution Agreement, dated December 29, 2006 (the "Asset Contribution Agreement"), pursuant to which, subject to the terms and conditions set forth therein, Assignor has agreed, among other things, to assign to Assignee all of its right, title and interest in and to certain trademarks registered with the United States Patent and Trademark Office and the appropriate offices of certain countries foreign to the United States and has filed applications for registration of trademarks (collectively, the "Trademark Applications") with the United States Patent and Trademark Office and the appropriate offices of certain countries foreign to the United States, in each case as and to the extent set forth on Exhibit A hereto, (the "Marks"), together with the goodwill of the Assignor's business ("Business") pertaining thereto.

NOW, THEREFORE, in consideration of the foregoing premises, the covenants and agreements in this Assignment, Assignor agrees as follows:

1. Assignor does hereby sell, transfer, convey, assign and deliver to Assignee all of Assignor's right, title and interest in and to the Marks, together with the goodwill of the Business pertaining thereto, the same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns and other legal representatives, as fully and entirely as the same would have been held and enjoyed by Assignor if this Assignment had not been made; together with all claims for damages by reason of past infringements of the Marks, along with the right to sue for and collect such damages for the use and benefit of Assignee and its successors, assigns and other legal representatives.
2. Assignor hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record Assignee as the assignee of all of Assignor's right, title and interest in and to the Marks in accordance with the terms of this instrument.
3. Assignor hereby represents and warrants that Assignor has the full power and has taken all necessary action to make the present assignment. Assignor further agrees that Assignor will, without demanding any further consideration therefor (other than such reasonable expenses as may be agreed upon by the parties from time to time), at the request of Assignee do all lawful and just acts including the execution and acknowledgment of instruments, that may be or become necessary for maintaining and perfecting and enforcing Assignee's rights in and to the Marks, particularly in cases of interference and litigation. Assignor makes no other representations or warranties herein regarding either this assignment or the subject matter thereof.
