

Pursuant to the Oregon Business Corporation Act and the Tennessee Revised Limited Liability Company Act, the undersigned entities adopt the following Certificate of Merger for the purpose of merging into a single company:

1. Parsam Technologies, LLC, a Tennessee limited liability company, is the merging entity (the "Merging Party") and was formed on February 1, 1999.
2. Harland Financial Solutions, Inc., an Oregon corporation, is the surviving entity (the "Surviving Party") and was formed on March 6, 1978.
3. The effective date and time of the merger is to be 11:59 p.m. E.S.T. on December 31, 2011.
4. The agreement and plan of merger (the "Merger Agreement") has been approved and executed by each constituent party to the merger and the sole member of the Merger Party on December 21, 2011 in accordance with the Oregon Business Corporation Act and the Tennessee Revised Limited Liability Company Act. No approval by the shareholders of the Surviving Party is required under the Oregon Business Corporation Act.
5. A copy of the Merger Agreement is attached hereto and is on file at the place of business of the Surviving Party. A copy of the Merger Agreement will be furnished by the Surviving Party upon request and without cost, to any person holding an interest in a constituent party to the merger. The principal office of the Surviving Party is located at 400 SW 6th Avenue, Suite 200, Portland, Oregon 97204.
6. The Surviving Party agrees that it may be served with process in the state of Tennessee in any proceeding for the enforcement of any obligation of the Merging Party, and hereby irrevocably appoints the secretary of state as its agent to accept service of process in any such proceeding.
