## SHORT-FORM TRADEMARKS SECURITY AGREEMENT

WHEREAS, Pergo (Europe) AB (the "Grantor") has adopted, used, is using, or intends to use, and is the owner of the trademarks and trademark applications listed in the attached Schedule of Registered Trademarks, and the registrations and applications associated therewith;

WHEREAS, the Grantor has contemporaneously with the execution of this Short-Form Trademarks Security Agreement entered into the Security Agreement dated as of January 30, 2012 (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement"), in which the Grantor has granted certain interests in favor of Commerzbank AG, Filiale Luxemburg, as restated security agent (the "Restated Security Agent") for the benefit of the Secured Finance Parties (as defined therein); and

WHEREAS, pursuant to the Security Agreement, the Grantor has agreed with the Restated Security Agent and the Secured Finance Parties to execute this Short-Form Trademarks Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby grants to the Restated Security Agent for the benefit of the Secured Finance Parties, to the extent provided in the Security Agreement, as collateral security for the prompt and complete payment and performance when due of all the Secured Claims (as defined in the Security Agreement), a security interest in all of its right, title and interest in, to and under each of the following (whether now owned or hereinafter acquired): (i) all trademarks (including, without limitation, the trademarks listed on the Schedule of Registered Trademarks attached hereto), all trade names, service marks, logos, and all trademark and service mark registrations, in each case, with the product lines and goodwill of the business connected with the use of, and symbolized by, each such trademark, trade name and service mark; (ii) all applications for trademark and service mark registrations, including all renewals of trademark and service mark registrations (excluding any application for registration of a trademark filed on an intent-to-use basis solely to the extent that, and for so long as, the grant of a security interest in any such trademark application would materially adversely affect the validity or enforceability of the resulting trademark registration or result in cancellation of such trademark application); (iii) all rights to recover for all past, present and future infringements of any of the foregoing, and all rights to sue therefor; and (iv) all other rights corresponding to any of the foregoing throughout the world (all of the foregoing, collectively, the "Trademark Collateral"). Notwithstanding the foregoing, in the event of any conflict between this Short-Form Trademarks Security Agreement and the Security Agreement, the Security Agreement shall control. The Grantor does hereby further acknowledge and affirm that the rights and remedies of the Restated Security Agent with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.




