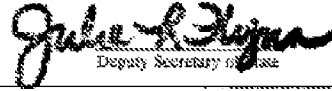

THIRD: The corporation's new jurisdiction of incorporation is Florida

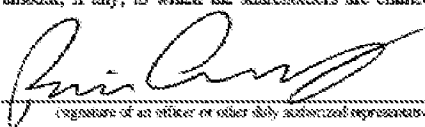

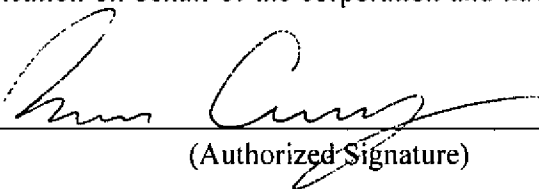
