REASSIGNMENT AND RELEASE OF SECURITY INTEREST

This Reassignment and Release of Security Interest (this "Release") is made and executed as of January 25, 2012 by Compass Horizon Funding Company LLC (the "Assignor") for the benefit of StarCite, Inc., a Delaware corporation ("Assignee").

RECITALS

A. WHEREAS, pursuant to the Venture Loan and Security Agreement, dated as of February 3, 2009, between Assignor and Assignee (the "Security Agreement"), Assignee granted certain interests in the intellectual property to the Assignor under the Security Agreement and a certain Grant of Security Interest, dated as of February 3, 2009 (the "IP Security Agreement"), including the intellectual property described on Exhibit A and Exhibit B, together with, among other things, the goodwill of the business symbolized by the intellectual property and the applications and registrations thereof, and all proceeds thereof, including, without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (the "Intellectual Property"), and recorded the IP Security Agreement with the U.S. Patent and Trademark Office the "USPTO") on February 10, 2009 at Reel 022263 Frame 0594 and at Reel 3941 Frame 0877; and

B. WHEREAS, the Assignor wishes to release and reassign all interest that Assignor may have in the Intellectual Property.

AGREEMENT

Now, therefore, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor hereby unconditionally terminates, releases and discharges its security interest in the Intellectual Property and unconditionally reassigns to Assignee, without warranty or recourse, all interest of Assignor in the Intellectual Property.

Assignor hereby authorizes the recordation of this Release with the USPTO and any other applicable registry.

This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the law of the State of California.

All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement.
