## **RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release") is made as of January 31, 2012 in favor of THOMAS LICENSING, LLC, HIT ENTERTAINMENT, INC., LYRICK STUDIOS, INC., LEN-JJ, CORP., LYONS ENTERTAINMENT OF NEVADA, INC., RHENCLID, INC., LYONS PARTNERSHIP, L.P., JOKER, INC., GULLANE (THOMAS) LLC AND GUINNESS WORLD RECORDS NORTH AMERICA, INC. (collectively, "Grantors") by CANTOR FITZGERALD SECURITIES (as successor to Deutsche Bank AG), as second lien administrative agent for the Secured Parties (in such capacity, the "Administrative Agent"). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Credit Agreement (as defined below).

**WHEREAS**, HIT Entertainment, Inc. entered into that certain Credit Agreement by and between HIT Entertainment, Inc., Deutsche Bank AG and the other parties thereto dated August 26, 2005 (the "Credit Agreement") and each Grantor entered into that certain Security Agreement by and between Grantors, Deutsche Bank AG and the other parties thereto dated August 26, 2005 (the "Security Agreement");

**WHEREAS**, pursuant to the Security Agreement, Grantors granted to Deutsche Bank AG a security interest in all of their right, title and interest in and to certain intellectual property and, in connection therewith, entered into that certain Second Lien Intellectual Property Security Agreement dated August 26, 2005 (the "IP Security Agreement") for the purpose of recording such security interest with respect to the Collateral (as such term is defined in the IP Security Agreement), which included the trademarks set forth on Schedule A hereto, with the United States Patent and Trademark Office;

**WHEREAS**, the IP Security Agreement was recorded with the United States Patent and Trademark Office on September 19, 2005, at Reel 003226, Frame 0001; and

**WHEREAS**, Grantors have paid all of their outstanding indebtedness to the Administrative Agent.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties (i) terminates the IP Security Agreement, (ii) terminates, cancels and releases any and all security interests it has against the Collateral, and (iii) re-assigns to Grantors any right, title and interest it may have in, to and under the Collateral.

The Administrative Agent shall, at Grantors' expense, take all further actions, and provide to Grantors, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by Grantors to more fully and effectively effectuate the purposes of this Release.

This Release shall be governed by and construed in accordance with the laws of the State of New York.

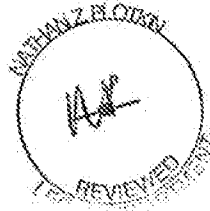
