3. Assignor agrees to take any and all actions necessary to assist Assignee in the transfer of the aforementioned Trademark including, but not limited to, filings required with the USPTO.

4. Assignor and Assignee each covenant and agree that they will at any time and from time to time do, execute, acknowledge, deliver (and cause to be recorded among public records as applicable) any and all other acts, deeds, assignments, transfers, conveyances, powers of attorney, releases, discharges, orders of satisfaction or other instruments that Assignee reasonably deems necessary or appropriate to carry out the assignment and conveyance intended to be made hereunder.

5. Assignor and Assignee agree to indemnify and hold one another harmless for all damages, costs and expenses (including, but not limited to reasonable attorneys' fees) arising out of or related to any breach of this Assignment or the representations or warranties set forth herein.



and all such facsimile or electronic signatures shall be deemed originals.






