Release of Lien on Trademarks

WHEREAS, the Agreement was recorded with the United States Patent and Trademark Office on May 1, 2007 on reel 3532 frame 0768;

WHEREAS, the Collateral Agent desires to release its security interest in and lien on the trademarks set forth on Schedule A hereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Collateral Agent does hereby release its security interest in and lien on the trademarks set forth on Schedule A hereto and reassigns to the Pledgors all right, title and interest of the Collateral Agent in and to such trademarks.


