ARTICLES OF CONVERSION Corporations Section

OF

THE ALAMO TRAVEL GROUP, INC.

Pursuant to the provisions of Article 5.17 of the Texas Business Corporation Act and Section 2.15 of the Texas Revised Limited Partnership Act, the undersigned converting entity certifies the following Articles of Conversion adopted for the purpose of effecting a conversion in accordance with the provisions of the Texas Business Corporation Act and the Texas Revised Limited Partnership Act.

1. A plan of conversion was approved and adopted in accordance with the provisions of Article 5.03 of the Texas Business Corporation Act providing for the conversion of The Alamo Travel Group, Inc., a Texas business corporation formed under the Texas Business Corporation Act, to The Alamo Travel Group, L.P., a Texas limited partnership.

2. An executed plan of conversion is on file at the principal place of business of the converting entity at 9000 Wurzbach Road, San Antonio, Texas 78240-1038, and, from and after the conversion, an executed plan of conversion will be on file at the principal place of business of the converted entity at 9000 Wurzbach Road, San Antonio, Texas 78240-1038.

3. A copy of the plan of conversion will be furnished by the converting entity (prior to the conversion) or by the converted entity (after the conversion) on written request and without cost to any shareholder or member of the converting or converted entity.

4. The approval of the plan of conversion was duly authorized by all action required by the laws under which The Alamo Travel Group, Inc. was incorporated and by its constituent documents.

5. The number of outstanding shares of each class or series of stock of The Alamo Travel Group, Inc. entitled to vote is Five Thousand (5,000) of common stock.

6. The number of shares, not entitled to vote only as a class, voted for and against the plan of conversion, respectively, and, if the shares of any class or series are entitled to vote as a class, the number of shares of each such class or series voted for and against the plan of conversion respectively are: Five Thousand (5,000) shares of common stock voted for the plan of conversion, and Zero (0) shares of common stock voted against the plan of conversion.

7. The entity created by the conversion will be liable for the payment of all fees and franchise taxes that might be owed by the entity being converted.


8. Two copies of the Certificate of Limited Partnership of The Alamo Travel Group, L.P., which is being created pursuant to the plan of conversion, are being filed with the Secretary of State with these Articles of Conversion.

9. The effective time and date of the conversion will be 11:59 PM on December 31, 2005.


