**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** ("Agreement"), dated as of January 22nd, 2012, is by and between Merchant Factors Corp. with an office at 1430 Broadway, New York, New York 10018 ("Factor"), with respect to the Factoring Agreement (as defined herein) and Komex International, Inc., a California corporation having its principal place of business at 736 E. 29th Street, Los Angeles, California 90011 (the "Company" or "Komex").

WHEREAS, pursuant to the terms of the Factoring Agreement, dated July 11, 2011 by and between Factor and the Company (the "Factoring Agreement"), which granted Factor a security interest in Komex's trademarks, and which security interest was recorded with the U.S. Patent and Trademark Office on July 18, 2011 (Trademark Reel 4585 and Frame 0398), the Company granted to the Factor a security interest in Komex's trademarks, trademark registrations and trademark applications, including the trademarks identified on Schedule A attached hereto (such trademarks referred to herein as the "Named Trademarks"); and


WHEREAS, Factor has agreed to terminate and release its security interest and all of its right, title and interest in each of the Named Trademarks as herein provided;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Factor and the Company hereby agree as follows:

1. **Release and Assignment.** The Lender hereby terminates and releases its security interest in and to all of Komex's Named Trademarks, and Factor hereby assigns and transfers to the Company, without recourse, all of Factor's right, title and interest in and to each of the Named Trademarks, to the extent such rights exist.
2. **Acknowledgment and Acceptance.** Komex hereby acknowledges and accepts the foregoing release and assignment by Factor.
3. **Counterparts.** This Release may be executed in any number of counterparts which shall together constitute one and the same agreement.


IN WITNESS WHEREOF, the Company and Komex have executed this Release, to take effect as of the 22nd day of January, 2012.


