**SECOND CERTIFICATE OF AMENDMENT
TO FIRST AMENDED AND RESTATED CERTIFICATE OF INCORPORATION
OF

LearningGuide Solutions, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"),

DOES HEREBY CERTIFY:

FIRST: The Corporation's First Amended and Restated Certificate of Incorporation (the "Restated Certificate") was filed with Secretary of State of the State of Delaware on March 14, 2011, and a Certificate of Amendment of LearningGuide Solutions, Inc. was filed with the Secretary of State of the State of Delaware on June 13, 2011.

SECOND: The board of directors of the Corporation adopted this Second Certificate of Amendment in accordance with the provisions of Sections 141(f) and 242 of the Delaware General Corporation Law and directed that the Second Certificate of Amendment be submitted to the Corporation's stockholders for approval, declaring its advisability.
