ASSIGNMENT OF GRANT OF SECURITY INTEREST (TRADEMARKS)

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, **ORIX FINANCE CORP.**, as resigning administrative agent (in such capacity, the "*Original Agent*") for certain lenders (the "*Lenders*"), hereby assigns to **WELLS FARGO FOOTHILL, INC.**, a California corporation, as the successor administrative agent for the Lenders (in such capacity, the "*Successor Agent*"), all of the Original Agent's right, title and interest in, to and under that certain Grant of Security Interest (Trademarks), dated as of November 17, 2004 (the "*Security Agreement*"), executed by **SMITH MEDIA, LLC**, a Delaware limited liability company (the "*Grantor*"), in favor of **THE BANK OF NEW YORK ("BNY")**, granting a security interest in those trademarks set forth on Schedule A attached hereto (the "*Trademarks*") and recorded in the United States Patent and Trademark Office on November 24, 2004, Reel/Frame 002980/0141, which security interest was subsequently assigned by BNY to the Original Agent pursuant to that certain Assignment of Grant of Security Interest (Trademarks), dated as of January 7, 2008 (the "*Original Assignment*"), by and among the Grantor, BNY, and the Original Agent.


