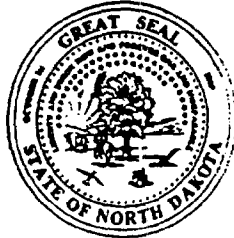

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION

Pursuant to the provisions of Chapter 10-19.1-21 of the North Dakota Century Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE 1. The name of the corporation is Phillips Temro, Inc.

ARTICLE 2. An amendment to the Articles of Incorporation was adopted on December 1, 1994.

ARTICLE 3. The amendment adopted is as follows:

The Articles of Incorporation be amended so as to change the name of the Corporation from PHILLIPS TEMRO, INC., its present name, to PHILLIPS & TEMRO INDUSTRIES INC., and that to such end Article I be changed to read as follows:

"The name of said corporation shall be 'Phillips & Temro Industries Inc.'"

ARTICLE 4. The manner, if not set forth in such amendment, in which any exchange, reclassification or cancellation of issued shares provided for in the amendment shall be effected, is as follows:
