TRADEMARK RELEASE

TRADEMARK RELEASE, effective as of this 23<sup>rd</sup> day of December, 2011, given by Citizens Bank of Pennsylvania, as Collateral Agent ("Agent") to First Quality Products, Inc. and First Quality Baby Products, LLC (collectively "Grantor"), as follows:

WITNESSETH

WHEREAS, the Grantor has heretofore granted to the Agent a security interest in certain U.S. Trademarks, trademark registrations and trademark applications more particularly set forth in Schedule A attached hereto (the "Marks") to secure the Obligations (as defined in certain Security Agreements, dated as of January 31, 2003 and June 29, 2004, between the Agent and the Grantor (the "Security Agreements")); and

WHEREAS, the Agent wishes to release and restore all right, title and interest in and to the Marks to the Grantor and to dissolve any and all Liens and encumbrances respecting the Marks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby releases, discharges, quit claims and relinquishes unto the Grantor the security interest in the Trademarks set forth on Schedule A granted to Agent by the Grantor pursuant to the Security Agreements, which security was duly recorded on February 5, 2003, at Reel 2757, Frame 0193 (corrected and rerecorded on January 24, 2005, at Reel 3014, Frame 445), and on January 26, 2006 at Reel 3234, Frame 221, in the United States Patent and Trademark Office.
