TRADEMARK ASSIGNMENT

WHEREAS, Stieber GmbH (hereinafter "Assignor"), a German company, is the owner of certain common law rights in the United States in the trademark "STIEBER" and is the owner of record of U.S. Trademark Registration No. 4,018,722 for "STIEBER" (collectively, "Trademark Rights"); and

WHEREAS, Assignor wishes to assign all if its right, title and interest in and to the Trademark Rights to Altra Industrial Motion, Inc. (hereinafter "Assignee"), a Delaware corporation having its principal place of business located at 300 Granite Street, Suite 201, Braintree, Massachusetts 02184,

Assignor assigns, sells and sets over unto the Assignee, its successors, legal representatives and assigns, the entire right, title, and interest to the Trademark Rights, any and all rights and privileges associated with the Trademark rights, together with the goodwill of the business symbolized thereby and the right to bring suit and collect damages for past infringements thereof. Assignor hereby covenants and agrees that the Assignor will at any time upon the request and at the expense of the Assignee execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect said right, title, and interest and said rights and privileges in Assignee, its successors, assigns and legal representatives.
