## TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of January 31, 2012, is made by **WELLS FARGO CAPITAL FINANCE, LLC** a Delaware limited liability company (f/k/a Wells Fargo Foothill, LLC), in its capacity as administrative agent for the Lender Group and the Bank Product Providers (the "Agent").

**WHEREAS**, (i) **EMPTORIS, INC.**, a Delaware corporation ("Emptoris") has granted a security interest in certain personal property to the Agent, including without limitation a security interest in certain trademarks and trademark applications ("Trademarks"), pursuant to that certain Trademark Security Agreement dated as of March 28, 2008 and (ii) **RIVERMINE SOFTWARE, INC.**, a Delaware corporation ("Rivermine") and **MBG EXPENSE MANAGEMENT, LLC**, a New York limited liability company ("MBG"), have granted a security interest in certain personal property to the Agent, including without limitation a security interest in certain Trademarks, pursuant to that certain Trademark Security Agreement dated as of December 23, 2010. Emptoris, Rivermine and MBG are referred to herein, collectively, as the "Grantors" and each individually, as the "Grantor."

**WHEREAS**, the security interests granted to the Agent were recorded at the United States Patent and Trademark Office as follows: on March 31, 2008 at Reel 003749 and Frame 01844 and on January 7, 2011 at Reel 004448 and Frame 0855; and

**WHEREAS**, the Agent has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto.

**NOW, THEREFORE**, for valuable consideration, the Agent hereby terminates and releases all mortgages, liens, and security interests granted to the Agent in the following:

1. all of the Grantors' Trademarks including those referred to on Schedule A attached hereto;
2. all goodwill of the business connected with the use of, and symbolized by, each Trademark; and
3. all products and proceeds of the foregoing, including, without limitation, any claim by any Grantor against third parties for past, present or future (i) infringement or dilution of any Trademark or (ii) injury to the goodwill associated with any Trademark.
