Pursuant to the provisions of Section 242 of the General Corporation Law of the State of Delaware, TidalTV, Inc., a Delaware corporation (the "**Corporation**"), hereby certifies as follows:

1. The name of the Corporation is TidalTV, Inc. The Corporation was incorporated pursuant to a Certificate of Incorporation filed with the Secretary of State of the State of Delaware on January 16, 2008 (the "**Original Certificate**"). The Original Certificate was amended in its entirety pursuant to a Certificate of Merger filed with the Secretary of State of the State of Delaware on January 31, 2008 (the "**Amended Certificate**"). The Amended Certificate was amended pursuant to a Certificate of Amendment of Amended Certificate of Incorporation filed with the Secretary of State of the State of Delaware on February 22, 2008 (the "**Certificate of Amendment**"). The Amended Certificate, as amended by the Certificate of Amendment, was amended in its entirety pursuant to a Restated Certificate of Incorporation filed with the Secretary of State of Delaware on October 2, 2009 (the "**Restated Certificate**"). The Restated Certificate was amended pursuant to a Certificate of Amendment of Restated Certificate of Incorporation filed with the Secretary of State of the State of Delaware on December 30, 2009 (the "**2009 Certificate of Amendment**"). The Restated Certificate, as amended by the 2009 Certificate of Amendment, was amended in its entirety pursuant to a Second Restated Certificate of Incorporation filed with the Secretary of State of the State of Delaware on March 8, 2011 (the "**Second Restated Certificate**").

2. This Certificate of Amendment of Second Restated Certificate of Incorporation amends certain provisions of the Second Restated Certificate, and has been duly adopted by unanimous written consent of the Board of Directors of the Corporation and by written consent of the holders of the outstanding stock of the Corporation entitled to vote thereon in accordance with the provisions of Sections 228 and 242 and all other applicable provisions of the General Corporation Law of the State of Delaware.

3. The text of the Second Restated Certificate is hereby amended as follows:

Article FIRST of the Second Restated Certificate shall be deleted in its entirety and replaced with the following:

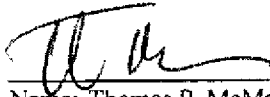
"**FIRST:** The name of this corporation is Videology, Inc. (the "**Corporation**")."
