**RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "Release"), dated as of February 3, 2012, is made by **CIT LENDING SERVICES CORPORATION**, as administrative and collateral agent (the "Agent"), under the Omnibus Pledge and Security Agreement referred to below.

**WHEREAS**, Mity-Lite, Inc., a Utah corporation (the "Company") is a party to that certain Omnibus Pledge and Security Agreement, dated as of July 17, 2007 (as amended, restated, supplemented or otherwise modified from time to time, the "**Omnibus Pledge and Security Agreement**"), made by the Company and the other pledgors named therein in favor of the Agent; and

**WHEREAS**, pursuant to (i) the Omnibus Pledge and Security Agreement, (ii) that certain Security Agreement (Trademarks) dated as of July 17, 2007 (the "**Original Trademark Security Agreement**") made by the Company in favor of the Agent and (iii) that certain Security Agreement (Trademarks) dated as of December 12, 2011 (the "**Second Trademark Security Agreement**"; and together with the Original Trademark Security Agreement, the "**Trademark Security Agreements**") made by the Company in favor of the Agent, the Company granted to the Agent a security interest in the Collateral (as defined in each of the Trademark Security Agreements), including the Trademarks listed on Annex I attached hereto;

**WHEREAS**, the Original Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on July 20, 2007, on Reel/Frame 3593/0459; and

**WHEREAS**, the Second Trademark Security Agreement was recorded in the U.S. Patent and Trademark Office on December 14, 2011, on Reel/Frame 4679/0084.

**NOW THEREFORE**, the Agent hereby releases, without representation, recourse or warranty whatsoever, its security interest in the Collateral granted pursuant to the Omnibus Pledge and Security Agreement and the Trademark Security Agreements, and the Agent hereby reassigns any and all such right, title and interest (if any) that the Agent may have in the Collateral to the Company.

The Agent agrees, at the Company's expense, to cooperate with the Company to provide the Company with any additional information or authorization reasonably required or desirable to effect the release of the Agent's security interest in the Collateral.
