TRADEMARK RELEASE

THIS TRADEMARK RELEASE AND REASSIGNMENT is made as of January 31, 2012 by **GENERAL ELECTRIC CAPITAL CORPORATION**, a Delaware corporation, as Agent (“Agent”).

WITNESSETH:

WHEREAS, Agent and **THERMASYS CORPORATION**, a Delaware corporation (“Grantor”), were parties to that certain Trademark Security Agreement dated as of December 17, 2010 (the “Agreement”), pursuant to which Grantor granted a security interest to Agent in certain trademarks (the “Trademarks”) and Trademark Collateral (as defined below) as security for certain obligations owing by Grantor to Agent, including the Trademarks set forth on Schedule 1 hereto; and

WHEREAS, the Agreement was recorded by the United States Patent and Trademark Office on December 22, 2010 at Reel 004438 Frame 0951; and

WHEREAS, Grantor has requested that Agent release its security interest in and lien on the Trademarks and Trademark Collateral and reassign the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Capitalized terms used herein without definition are used as defined in the Guaranty and Security Agreement dated December 17, 2010 among Grantor, Agent and certain other parties thereto.

2. Agent hereby releases and discharges fully its Lien on and security interest in all of Grantor’s right, title and interest in, to and under the following (collectively, the “**Trademark Collateral**”):

(i) all of its Trademarks and all IP Licenses providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto;

(ii) all renewals or extensions of the foregoing;

(iii) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark license; and

(iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past,

present and future infringement, misappropriation, dilution, violation or other impairment thereof.

3. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Trademarks and Trademark Collateral.
